Management Discussion of Fund Performance

This management discussion of Fund performance presents views of the portfolio management team about the significant factors and developments during the past six months that have affected the Fund's performance and outlook since March 31, 2009, the Fund's most recent fiscal year-end. This report should be read in conjunction with the annual Management Report of Fund Performance for the year ended March 31, 2009.

The commentary in this section is general information about the Fund's recent performance. For more information on the Fund's longer-term performance, please refer to the section under Past Performance later in this report.

Results of Operations

(based on information as of September 30, 2009)

The Fund's net assets increased by 33.0% during the period to \$1.3 billion. This change was comprised primarily of gains of \$217.4 million from investment operations and an increase of \$111.8 million due to net proceeds from the issuance of the Fund's securities. Average net assets of the Fund for the period were \$1.2 billion (2008 – \$1.1 billion), an increase of 7.9% compared to the six-month period ended September 30, 2008. Average net assets influence revenue earned and expenses incurred by the Fund during the period. The Fund's performance is discussed below. Performance will vary by series largely due to the extent that fees and expenses may differ between series. See Series Information later in this report.

The Fund significantly outperformed the DEX Universe Total Return Index over the six-month period ended September 30, 2009. In an environment where equities generally outperformed fixed-income securities, a 60% allocation to Funds invested in these better-performing markets boosted the Fund's performance.

The Fund underperformed the S&P/TSX Composite Index over the period given the fact that 40% of its assets are allocated to fixed income. As noted above, the performance of fixed-income markets generally lagged the performance of equities over the last six months.

Security selection within the energy and materials sectors helped the Fund's performance. Underexposure within the financials sector, in particular the banking industry, was the largest detractor of performance during the period.

Within its equity component the Fund maintained a neutral sector allocation relative to its benchmark during the period. Instead, security and industry selection drove the Fund's performance. The Fund's exposure to the financials sector increased during the period, while exposure was reduced in the materials and energy sectors. From an asset allocation perspective, exposure to equities was increased during the period. Exposure to cash and fixed income was reduced during the period.

Lastly, within the bond portfolio, the Fund maintained its under-allocation to federal government bonds relative to the benchmark, while continuing to favour corporate issues, asset-backed securities and securities backed by commercial mortgages. This positioning contributed to performance as corporate issues outperformed government bonds.

Recent Developments

(based on information as of October 23, 2009)

As a result of significant, coordinated stimulus actions by central bank authorities around the world, global capital markets responded to data showing early signs of economic recovery. This response had a positive impact on Fund returns.

In the short term, the portfolio management team expects volatility to continue in equity markets. The continued U.S. unemployment and general weakness in global business conditions are casting doubts on a quick economic recovery. The portfolio management team will be looking at ways to benefit from current conditions, and remains bullish on Canada's position to benefit from growth in global infrastructure over the longer term.

The Fund remains primarily invested within Canada as the portfolio management team believes longer-term global growth-driven demand will continue for commodities. With respect to the Fund's bond portfolio, the portfolio management team continues to prefer shorter-maturity Canadian financial issues.

Within fixed income, the portfolio management team continues to explore opportunities in select Canadian credit issues, believing that prices have fallen below fundamental value and expects to maintain the Fund's positions in high-yield bonds and convertible securities.

Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor has been retained to provide investment services to the Fund:

- Fidelity Investments Canada ULC.

The Fund paid 2.00% (per annum) of its net assets to the Manager and Portfolio Advisor, in aggregate, for management and portfolio advisory services (see Management Fees).

The Fund paid the Manager an administration fee, including applicable implementation period adjustments, equal to 0.21% annually of the net assets attributable to Series A and B, and 0.19% annually of the net assets attributable to Series C. In exchange for the administration fee, the Manager pays the operating costs and expenses of the Fund, except for certain specified Fund costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of units. The Fund paid the Distributors 0.30% annually of the net assets attributable to Series A, 0.45% annually of the net assets attributable to Series B, and 0.50% annually of the net assets attributable to Series C. A portion of the service fee for Series C is rebated by the Distributors to the Fund quarterly as outlined in the Prospectus. This rebate is paid as a return of capital distribution to eligible unitholders and is reinvested in additional Series C units.

The Trustee is responsible for the overall direction and management of the affairs of the Fund. The Trustee is paid an annual fee of 0.05% of the average net assets of the Fund for its services.

IGM Financial Inc. is a subsidiary of Power Financial Corporation and Power Corporation of Canada. Power Financial Corporation also owns a majority of Great-West Lifeco Inc. and related insurance companies and, therefore, those companies are considered affiliates of the Manager. As of September 30, 2009, the Fund held common shares of Power Corporation of Canada valued at \$0.6 million. This investment represents less than 0.1% of the Fund's net assets and is in accordance with standing instructions approved by the Independent Review Committee.

¹ These calculations are prescribed by securities regulations and are not intended to be a reconciliation between opening and closing net assets per unit. This information is derived from the Fund's unaudited interim financial statements and audited annual financial statements. Effective after the close of business on September 30, 2008, the financial year-end of the Fund changed from September 30 to March 31. The Fund's year-end for tax reporting purposes is unaffected by this change.

² The net assets per security presented in the financial statements may differ from the net asset value calculated for Fund pricing purposes. This difference is due to the requirements of generally accepted accounting principles ("GAAP"), including CICA Handbook Section 3855, and may result in a different valuation of securities held by the Fund in accordance with GAAP than the market value used to determine net asset value of the Fund for the purchase and redemption of the Fund's units ("pricing NAV"). The impact of the adoption of this accounting policy for valuation of securities on the net assets per unit determined in accordance with GAAP as of October 1, 2006 was (0.01) for all series. The pricing NAV per unit at the end of the period is disclosed in Ratios and Supplemental Data.

³ Net asset value and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of units outstanding over the financial period. In the period a series is established, the financial information is provided from the date of inception to the end of the period.

⁴ Distributions were paid in cash, reinvested in additional units of the Fund, or both.

⁵ Management expense ratio (MER) is based on total expenses, excluding commissions and other portfolio transaction costs, for the stated period and is expressed as an annualized percentage of daily average net assets during the period, except as noted. In the period a series is established, the management expense ratio is annualized from the date of inception to the end of the period.

For Series C, the service fees are divided by the assets attributable to Series C on the days on which the fee is charged. The MERs presented for Series C represent the maximum MER applicable to any account because service fee rebates have not been offset against service fees. Eligible clients in Series C are entitled to a rebate of service fees based on their asset levels held in the Fund and in other Investors Group mutual funds as outlined in the Fund's Prospectus. The rebate is distributed as a return of capital distribution to eligible unitholders and is required to be reinvested in additional Series C units at the net asset value per unit on the distribution date. Clients may receive a rebate in an amount of up to all of the service fees paid in Series C based on their asset levels held in their Fund(s). The annualized MER's for the six-month period ended September 30, 2009 are: Min. MER: 2.35%; Weighted Average MER: 2.47%; Max. MER: 2.85%.

Certain expenses that are non-recurring and/or otherwise uncertain as to their future timing and amount have not been annualized.

⁶ The trading expense ratio represents total commissions and other portfolio transaction costs incurred as an annualized percentage of daily average net assets during the period.

⁷ The Fund's portfolio turnover rate indicates how actively the Fund's Portfolio Advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a Fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a Fund. Costs incurred to realign the Fund's portfolio after a fund merger, if any, are excluded from the portfolio turnover rate.

Management Fees

The Fund pays Investors Group a management fee. The management fee paid by each series is calculated as a percentage of the net asset value of the series, as of the close of business on each business day (see Related Party Transactions for rates payable by each series). Management fees were used in part to pay costs incurred in providing investment advisory and management services, and distribution-related services including the cost of financial planning services, consultant commissions and bonuses, marketing and other Fund promotional activities and educational conferences.

For the six-month period ended September 30, 2009, on average approximately 54% of the total management fee revenues received from all Investors Group Funds was attributable to investment advisory and management services. The balance of these fees was used to fund the payment of distribution-related services.

For this Fund, investment advisory and management services represented approximately 41%, and distribution-related services represented approximately 59%, of the management fees paid for the six-month period ended September 30, 2009. This may vary by series depending upon the assets invested in each series.

Past Performance

It is important to remember that past performance doesn't necessarily indicate future performance. The returns presented below:

- assume that all distributions, except for service fee rebates, are reinvested into the Fund;
- do not include sales charges, income taxes, or optional expenses that reduce returns;
- show performance based on Canadian dollar returns; and
- show performance for the six-month period ended September 30, 2009 and for each of the past 10 financial years, or since the series started.

Financial years are as follows:

- 2000 to 2008 – up to 12 months ended September 30
- 2009 – six months ended March 31

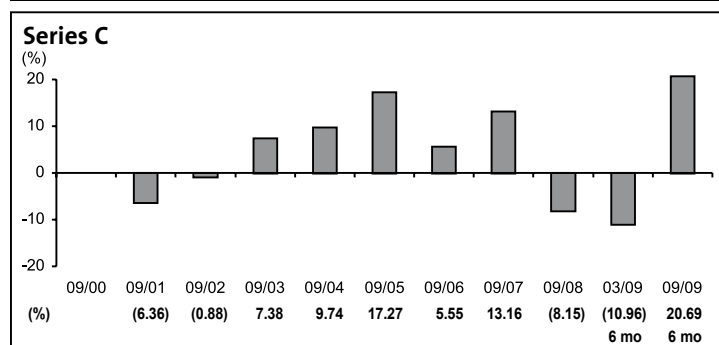
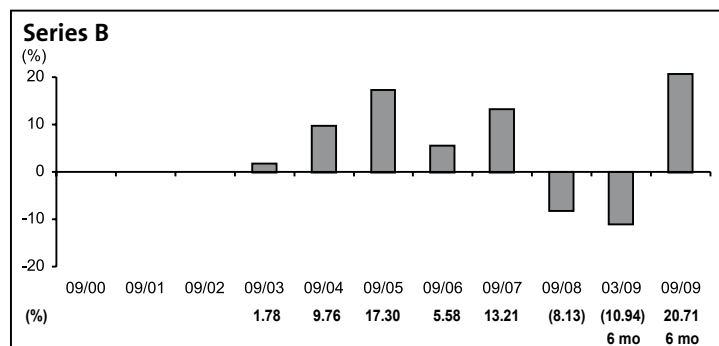
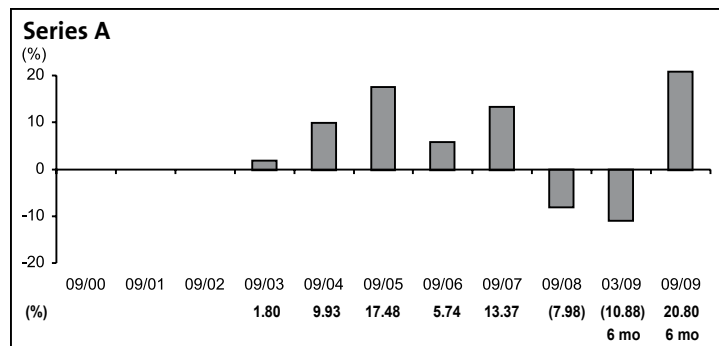

Performance during these periods may have been impacted by the following events:

- In July 2003, the annual management fee of the Fund decreased by 0.40% to 2.00%.
- In October 2007, the Fund began to pay an administration fee. In exchange, the Manager began to pay certain operating costs and expenses that had been paid by the Fund.
